Bid Specific Additional Terms and Conditions

- Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

Payment shall be released only after submission of documentary evidence of having Functional Service Centre.
